- 1 Call to order meeting was called to order at 12:05 pm
- 2 Approval of minutes from 2022 fall meeting (posted online) Minutes were approved

3 - Financial Report

Treasurer's Report was posted online and presented. No questions on report.

Budget was then presented. Mary Turner explained the numbers. Motion made to approve budget. Discussion: Athlete Proposal to add \$12,000 to the budget for Leadership Summit starting summer 2024. Other LSC's have such an item in their budgets. A Motion was made to add \$12,000 to the Athlete Leadership Camp line and removing Athlete Subsidize Spring Subsidy of \$4200. Discussion on entire budget adjustments. Vote was called and the motion was passed with no objections.

4 - Approval of Agenda- motion to approve agenda was passed.

5 - Report of Officers

1. Zone Directors Report - Tim Husson & Jerry Adams - report is posted.

Zone Directors and athletes are part of Zone Directors Council — meetings approximately once a month with other Zones. They now have a liaison directly with USA Swimming Board of Directors. SWIMS 3.0 is moving along, hopefully improvements will get rid of any hiccups. New Education module is coming. Reports have not been great — USA Swimming looking for a new vendor for reporting. It won't happen quickly but is on the horizon. LSC Records still have a long way to go. Workshop was good, we had EZ meeting where Beth and Nate spoke on how things were going. Motion to accept the report — motion passed.

2. Technical Planning Report - Tristan Formon

Technical Planning meeting was held earlier in the day. Minutes posted

5 proposals, that are posted on the web site, were made. R4 was pulled by Mary Turner. Would like to ask if it could start this summer if host is in agreement. The host will be contacted. Motion to accept R1, R2,R4,R5,R6 as an omnibus motion Motion passes, none opposed.

Allegheny Mountain requested the Zone look into the SC Age Group Zone meet and maybe moving back to an LSC supported and entered meet as opposed to current team entered format. Technical Planning recommends a task force to look into this with representatives form the 12 LSC's and report back in September. If interested in serving on the task force, please email Jerry Adams. Jerry Adams requests 5 on task force and report back to the LSC's to keep the task force manageable. He has a few names and needs athlete representation. Tim Husson mentioned that there could be a third choice, a hybrid version. Motion was made to accept tech planning report — motion carries, none opposed.

3. Report of Zone Championship Coordinator - Bud Rimbault

There is still no bid for LC Sectionals for the South for March of 2024 – if anyone is interested, please let Bud know.

There was an error on dates posted for Senior Zone Meet - LC 2024 - Should be August 1-4, 2024.

2025 Bids - please note Easter will be in April 20th and will not impact any meets for the EZ.

Proposed dates: Sectional Meets - March 20-23, 2025

Age Group Zones - March 26-29, 2025

Super Sectionals if hosted - May 15-18, 2025

Open Water - Depends on the bidder and water access, possibly June 14, 15., 2025

Senior Zones - July 31 - August 3, 2025

Age Group Zone - August 6-9, 2025

Question asked about 2024 LC Sectional South meet – if no bid then is the south out of luck for a meet, would we open North? Bud says no one has expressed interest at the time of the meeting. Jerry said we should have a plan by the fall meeting. May need to make north meet a super sectional. Bud will be resigning as Technical Chair and thanked everyone for helping during his time. Motion to accept report – all in favor – none opposed.

4. Athlete Representatives Report - Gavin Formon

Report is posted on line. The USAS workshop went pretty well, the AC had great programming again for the athletes. Everyone came back with projects for their LSC.Looking forward to next few months. There were LSC check ins.

Leadership retreat is coming up – looking forward to that. There has been a lot of interest. Gavin thanked everyone for their support and funding to keep it going. This will better the athletes going forward. Motion to accept report – all in favor – none opposed.

5. Age Group Chair Report - John Yearwood

Excited to hear we may be bringing back LSC Age Group meet for SC. Might help smaller teams sending athletes. His term is up – thanks everyone for the help. Motion to accept report – all in favor, none opposed

6. Diversity Equity and Inclusion Chair – Nadine Johnson-Jesionek

Nadine was not on the meeting

7. Officials Chair - Genny Kimbel

Genny reported that she has reached out to the LSC Official's Chairs and referees. She reported that spots were filling up for the LC meets but looking to fill the referee spots as quickly as possible. Motion to accept the report — all in favor, non oppsed.

8. Safe Sport Chair – Ann Koufman

Ann was not on the call. Tim Husson reported that she will be stepping down from this position, she is now the chair of the National safe sport committee. USA Swimming will recommend a replacement.

9. Disability Swimming Coordinator - Elizabeth Jester

Elizabeth reported that on a National level, the disability coordinators from all four zones and Jim Peter Fish, Disability Sub Committee Chair on the National level, have met many times to develop a form to facilitate athletes with disabilities in meets to help the referees with modifications and accommodations. This will help the ref know exactly what they need without confusion. This form should be ready soon and placed on all 4 Zone websites and then pushed to the LSC's. Motion to accept report — all in favor, none opposed.

6 - Old Business

 Policies and Procedures Task Force — task force from years ago started and needs to revamp. Tim Husson will start process, as we can't have Zone By-laws, so must use accurate Policy and Procedures Manual. Let Tim know if you are interested in serving on this task force. Hopefully a kick off meeting in next couple of weeks.

7 - New Business

- Zone Championship Coordinator Chair Replacement

With the resignations of Tristan and Bud – these positions will be open. Directors will be looking to appoint replacements to fill remainder of the terms. Please email them if you have any nominations.

8 Reports of National Committees

Mike Switalski — Club Development: There will be a series of webinars coming up, the first one coming up in the next month. They will be focused on swim clubs and strategic planning — setting a course for their future. Dry side of sport and that clubs are stable.

Mary Turner — Registration announced webinar is coming up for registrars and others who might want to attend. There will be a rolling out of a bulk renewal for teams to decide if they want to go back to the old way for clubs to renew athletes. This is for renewals not new registrations. There will be a new category for coaches, to be discussed later.

Marci Callan – Coaches Advisory Council – New Coaches designation – Provisional membership starting September 1, 2023 for 2024 registration. Introduction to coaching for a period of 3 years as opposed to coming in year one and taking all the courses. There will be lots of questions, and all the details aren't available now. No other coach designation has changed. Mike Seip – Operational Risk – Report on website. This is National Drowning Prevention Month – we will be rolling out a statement from USAS, YMCA and Red Cross on hypoxic training. There will also be a webinar later on in the month. Meet Marshall program is up and running. We encourage anyone running meets to have their meet marshal take the program. It's a great way to manage your risk and not increase your exposure should something bad happen at a meet. Marco is our certification expert and has been checking on certifications. We are working on guidelines for water temperature guidelines. Publication coming out soon to increase racing start awareness, which is a requirement in the rule book. Other areas being looked at – concussion protocol and disability waiver. Information will be given to general chair and operational risk chair of each LSC.

Tristan Formon – Age Group Development – Report is on website – The committee continues to work on different ways to track, recruit, retain age group families and athletes. Legislation to adjust the developmental competition category this fall to change some of the roles and programs and increasing tools for age group coaches.

<u>Critical</u> – if you are given the chance to vote for your LSC – Please ensure you exercise that right. Very few used that privilege last year. Find out who is voting in your LSC and if you have the opportunity to represent – please take it!

Jerry announced that Tristan is leaving the Eastern Zone/New Jersey Swimming for North Carolina. He has served as Technical Chair and Zone Director and has helped the Eastern Zone and keeping it together! We all thank Tristan and will miss him very much. Thank you for all you do and have done for swimming.

Jerry introduced Nate Chessey as one of our Eastern Zone liaisons to USA Swimming with Beth Wintkowski.

2023 Spring Meeting May 7, 2023 Zone Directors' Report

The mission of the Eastern Zone is to develop a unified organization designed to work in cooperation with the LSCs to support and promote the Eastern Zone Swimming Membership.

Zone Directors Council (ZDC)

The ZDC consists of the Coach, Non-Coach, and Athlete Directors of each of the four Zones. The Junior Athlete Representatives are also invited to participate. The ZDC meets regularly with USA Swimming staff to share information and provide feedback from the LSCs. Kathleen Prindle is now the ZDC Liaison on the USA Swimming Board. Tim is currently the ZDC Co-Chair along with Zach Toothman, the Athlete Director of the Central Zone.

SWIMS 3.0

After a rough start in September 2022, things seem to be settling in with SWIMS 3.0. There is still a lot of functionality to complete, but registration for the 2023 registration year is all but completed. Online Meet Entry (OME) just came online last month which should make entries for the summer meets easier than those in March.

A new user interface for the Education Module is scheduled to be launched in mid-May. That will hopefully alleviate some of the problems that have plagued those trying to complete their required training.

USA Swimming is also looking for new vendors for the reporting functionality which has not been up to the standards required for this new system.

A first cut at an LSC records capability has also been launched. There is still much work to be done on it.

USA Swimming Board Meeting

Tim attended the USA-S Board Meeting on April 20 in Denver where he and Zach Toothman made a presentation of ZDC status and plans.

The Board created a new Provisional Coach membership category, similar to the Junior Coach membership, but for those over the age of 18. Fewer initial requirements to get on deck is the key feature of this membership category. A coach can remain in this category for up to three years. This will be available in September 2023 for the 2024 Membership year. More details to follow.

Given the rough start of SWIMS 3.0, USA Swimming has enlisted the help of a consultant with major system development experience. An initial assessment by this consultant pointed out the problems in

the structure of the development and rollout of the system. He will help USA-S create a better path forward in the development of the system.

The Board is looking into providing insurance for pre-competitive & learn to swim program through the same insurance company used by the membership. The goal is to have a one-stop insurance provider for those USA-S clubs that also have these non-member developmental programs.

There was considerable discussion by the Board concerning recruiting and retaining membership. Membership is still below the peak of 2017. No specific plans or actions came out of the discussion.

At the USA Swimming Spring Workshop, April 20-23, 2034 in Denver, he USA Team Services representatives for the Eastern Zone, Reth Winkerweld and No. 21 representatives for the Eastern Zone, Beth Winkowski and Nate Chessey, gave a presentation to the EZ members in attendance. The presentation outlined their strategic plan to provide better service to the Zone, particularly in the area of communications.

There was a Legislative Session to discuss potential legislation for the 2023 HOD in September. Copies of the proposed legislation are available on the USA-S Rules & Policies webpage https://www.usaswimming.org/about-usas/governance/rules-policies

The workshop included tracks for LSC General Chairs (and other LSC Leaders), LSC Officials Chairs, LSC Safe Sport Chairs, Coaches, and New Referees.

2024 SECTIONALS & SNR ZONE PROPOSALS

These proposals were shared with the Technical Committee, EZ Directors and respective Meet Hosts for commentary, please see below.

PURPOSE: To afford a more inclusive opportunity for member clubs and athletes and create a similar competitive experience and opportunity across all meets.

EFFECTIVE DATE: SEPTEMBER 1st 2023

Recommendation for consideration by the Technical Committee:

R1. Each year the Zone receives requests by hosts to consider offering the 3.5 day format versus the full 4 day format. The intent is that this would be addressed prior to awarding of bids.

Require bidders to indicate their intention to run a 3 ½ Day or full 4 Day Format for Summer Super Sectionals at the time of bidding for consideration by the EZ General Meeting when awarding bids.

R2. For all EZ Sectional and Senior Zone Meets, Winter, Spring and Summer will permit any athlete qualified in 1 or more individual events the opportunity to swim up to 7 individual events. Essentially Make 1, 2, 3, 4, 5, 6 swim 7. Per the 2023 LC Super Sectional Meet in Buffalo wording:

If an athlete qualifies for one (1) event, they may swim in as many bonus swims as they would like, as long as they stay within the entry limits (no more than 3 events per day, no more than 7 total events).

- R3. Each year the Zone receives requests to permit a D final at one or more of the Sectional Meets, even though the 600 athlete cap has not been met. It is therefore proposed that all Sectional and Senior Zone Meets offer an A B C D Final for all Prelim/Final events with an age restriction of 18&U be placed on the D Final. (A B C open age) (See Commentary 1 C1 below)
- **R4. The SNR Zone Bonus Standards be removed.** Currently, the Sectional Events only have qualifying standards. It is suggested that the Snr Zone meet have a similar process for event participation qualification. (Standards to be approved following the EZ Tech Meeting)
- R5. With Safe Sport calling for two-deep leadership on team travel trips, the number of coaches deck passes to be increased for teams of 4 or less athletes to two deck passes versus one. Only the smallest sized teams would be impacted (positively) (wording appears in the meet announcement)
- R6. With the exception of EZ Sectional Meets in Olympic Year, the Sectional Meets will be limited to the 100 out of section athletes. Winter Sectionals: North go North, South go South plus up to 100 out of Zone athletes per meet. For Super Sectionals, limit to 100 out of Zone athletes per meet. On Olympic Years, all EZ Sectional Meets are restricted to EZ athletes only. Snr Zones is always limited to EZ Athletes.

Commentary Received:

Adam Kennedy: Thank you. It looks like a great agenda and I do not have more to add.

Mary Turner: Thanks for sending this. C1: Agree with all points but 3 from an admin perspective. It is very difficult to fill 4 heats in finals on Sunday night. Suggest changing wording in 6 to: "With the exception of <u>Super Sectional meets in an Olympic year..." C2: Even the SC Super Sectional in an Olympic year can be very large. (note C2 was incorporated)</u>

2024 AGE GROUP ZONES

At the recent USA Swimming Workshop, AMS requested the Zone reconsider the format of the Winter AG Zone meet. It is presently set up as an Age Group (14 & U) Invitational versus the traditional LSC entered All Star Meet. The Technical Committee will entertain a motion to return to the former LSC Entered All Star Meet and subsequent discussion.

MISCELLANEOUS: 9.1 Amendments: Any provision of the EZ Policy Manual (Sections 1 to 9) not prescribed by USA Swimming Bylaws may be amended at any meeting of the EZ by two-thirds (2/3) vote. At least thirty (30) days written notice must be given to the General Chair of each LSC of any proposed amendment. Any provision of the EZ Regulations (Sections 10 and 11) and the Appendices may be amended at any meeting of the EZ by simple majority of the votes cast.

Recommendations from the Technical Committee for approval/consideration by the body at the General Meeting:

R1. Require bidders to indicate their intention to run a 3 ½ Day or full 4 Day Format for Summer Super Sectionals at the time of bidding for consideration by the EZ General Meeting when awarding bids. Effective date: (For bids received on or after) September 1" 2024

R2. For all EZ Sectional and Snr Zone Meets, Winter, Spring and Summer, each athlete qualified in an individual event will receive 3 bonus swims. (Exception 800/1500 1000/1650 — Only athletes who qualify in the 800/1000 may elect to bonus the 1500/1650 and vice versa)

Effective date: September 1st 2023

R3. Withdrawn (see below)

R4. The SNR Zone Bonus Standards to be removed.

Effective date: September 1st 2023

R5. With Safe Sport calling for two-deep leadership on team travel trips, the number of coaches' deck passes to be increased for teams of 4 or less athletes to two deck passes versus one.

Effective date: September 1st 2023

R6. Participation by out of Zone athletes in Sectional meets:

- Senior Zones are restricted to Eastern Zone Athletes only.
- Winter Sectional Meets 100 out of Zone athletes allowed per meet. Teams in the north region must participate in the northern regional meet and teams in the south region must participate in the south regional meet.
- Super-Sectional Meets
 - o Non-Olympic years 100 out of Zone athletes allowed per meet.
 - Olympic years restricted to Eastern Zone athletes only.

Effective date: September 1st 2023

R3. WITHDRAWN Each year the Zone receives requests to permit a D final at one or more of the Sectional Meets, even though the 600 athlete cap has not been met. It is therefore proposed that all Sectional and Senior Zone Meets offer an A B C D Final for all Prelim/Final events with an age restriction of 18&U be placed on the D Final. (A B C open age)

2024 AGE GROUP ZONES

The Technical Committee considered the following request: "At the recent USA Swimming Workshop, AMS requested the Zone reconsider the format of the Winter AG Zone meet. It is presently set up as an Age Group (14 & U) Invitational versus the traditional LSC entered All Star Meet." The Technical Committee voted to create a taskforce / working group to research the potential for a full LSC supported/enter Winter Meet / HyBrid or retaining the current Club Team supported/entered format. This group will be tasked with returning a recommendation at the 2023 Fall EZ Meeting.
