1. **Call to Order** – Meeting was called to Order by Jamie Platt at 12:04 PM
2. **Approval of Agenda** – There was a motion/Second – Agenda was approved
3. **Approval of Minutes** – There was a motion/Second to approve the minutes of the Fall 2023 Minutes – Approved
4. **Financial Report** – Mary Fleckenstein went over current accounts, report was posted online – Motion/Second to approve – Approved
5. **Report of Officers** –
  - a. **Zone Directors** – Jamie Platt and Jerry Adams – report will be posted
  - b. **Technical Planning** – Pete Barry – Pete reported from meeting held May 5, 2024 Discussion on athletes who qualify for higher meets, meet format, 2026 bids to be taken for approval in September.
  - c. **Zone Championship Coordinator** – Tim Husson – will be looking for meet hosts in September
  - d. **Athlete Representative Report** – Gavin Formon, TJ Walsh – elections will be held this fall for Athlete and JR Athlete Directors, Summit is happening in June. LSC's are reporting activity with good plans.
  - e. **Age Group Chair** – John Fedena – Meet at Webster received good feedback. Discussion on meet information and format.
  - f. **Diversity, Equity and Inclusion** – Nadine Johnson – nothing new to report at this time
  - g. **Officials Chair** – Genny Kimbel – submitted written report, has been in contact with LSC official's chairs.
  - h. **Safe Sport Chair** – Will Gallagher – nothing to report at this time
  - i. **Disability Swimming Coordinator** – Elizabeth Jester – new DQ slips should be arriving soon. Parallel time standards should be used, refer to Article 105. These standards should be reviewed every 4 years. Modification list is waiting for final approval and branding. Website review – will all be updated and same on all sites applicable to Disability. This fall – proposals to language in P&P regarding language regarding athletes with disabilities.

Reports were approved – with exception of B,D,E,I

**B. Tech planning** - Pulled to discuss bonus events for Sectionals beginning 2026. Wording will be worked on and presented at the Fall meeting.

Discussion on removing the LC Sectional meet from the Spring schedule and running 2 SC Sectional meets and adding the LC meet only in Olympic Trial year. Motion/Second. Motion passed.

Report approved.

**D. Athletes** – Athlete Summit – being held at Bryn Mawr College June 20-23, 2024 with Middle Atlantic. Looking for 3 athletes from each LSC and 1 non-athlete chaperone. Will cost each LSC between \$100-\$300. Will be using EZ funds of \$12,000 to defray most of the cost. LSC will also provide transportation and 1 meal for the attendees. The schedule is full of practices, workshops and various other activities. Report was approved.

**E. Age Group** – John spoke about the format for EZ Age group SC Champs – a survey was done and is included with these minutes. Coaches were asked various questions about how the meet should be formatted. Will have a committee to review and update us in the fall. Report was approved.

**I. Disability** – Pulled to discuss Parallel standards – yes, they should be used. Report was approved.

## **6. Old Business**

- a. Eastern Zone Policies – TJ Walsh and Marco Greico reported the work is almost done – They are finalizing the technical areas and meet procedures. Goal is to have ready before the fall meeting for review.

## **7. New Business**

- a. Budget – Mary Turner presented the budget – included in the minutes. Discussion was held on charging dues again, as the account balance ending August 2025 will leave approximately \$8,000. Expenses for last year, this year and budgeted for next year are approximately \$20,000. This does not include a budget line for DEI camp. Except for years we held DEI camps and Athlete Summits our expenses were not this high. Eastern Zone previously charged each LSC \$.25 per premium athlete based on previous years numbers. EZ had approximately 71,000 athletes ending in August 2023. A Motion and second was made to amend the budget and charge each LSC \$.25 per premium athlete based on previous years numbers. LSC's went into breakout rooms and votes were sent to Jamie Platt. Motion for amendment was approved. Motion and second was made to accept the budget as amended – Motion was passed.
- b. Long Course Age Group Championships – Format will be the same, however, the 1500/800 will be split by gender to help with the timeline. Mary Turner requests each LSC to send her the name of the Zone Team Manager within 2 weeks for her to have contact with.  
John Fedena proposal for the rewording of the meet information as follows:

Amend the following in the meet information -

Eligibility of athletes with qualifying times for higher level meets:

1st point -

\*the USA Swimming SUMMER Junior Championship

Athletes who have competed in an individual event at USA Swimming national championships, USA Swimming Spring championships, US Open, USA Swimming SUMMER junior championships, or a USA Swimming Trials class meet are not eligible to enter and compete at an EZ AG championship meet.

2nd point -

No changes

Athletes 13 years of age and over who have achieved a qualifying time in an event for any of the above meets prior to the entry deadline for the EZ meet, may not enter and compete in an EZ AG championship meet.

3rd point -

\*Athletes 14 years of age and under who have achieved a qualifying time in an individual event for WINTER Junior Nationals but have not competed in that event at WINTER Junior Nationals may enter and compete in that individual event(s) in prelims ONLY at EZ AG Champs, additionally, they may NOT swim those strokes/distances on relays

The motion was made/seconded and approved.

Mike Switalski – Club Development – working in 2 groups Business and webinars to help get more information out to clubs

Elizabeth Antenucci – Safe Sport – continue with athlete and parent trainings, working on additional training on reporting resources.

Marci Callan – Coaches Advisory Committee – working with LSC coaches reps on job descriptions

Harper Freeman – Officials Committee – working on online testing and guidebooks.

### **R9 Benefits**

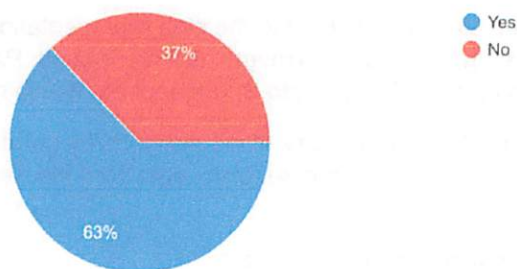
## COACHES SURVEY RESULTS

Below is the feedback from the coaches that attended the meet regarding these possible switches:

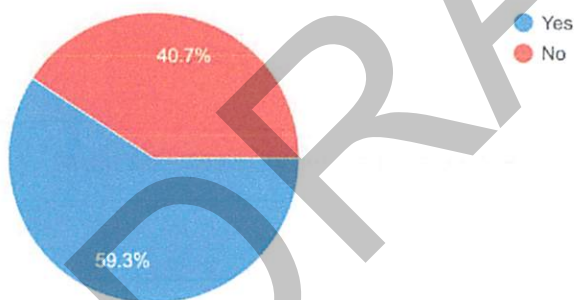
Currently the Age Group Short Course meet is an open format for teams to enter as a team. Do you like this model?

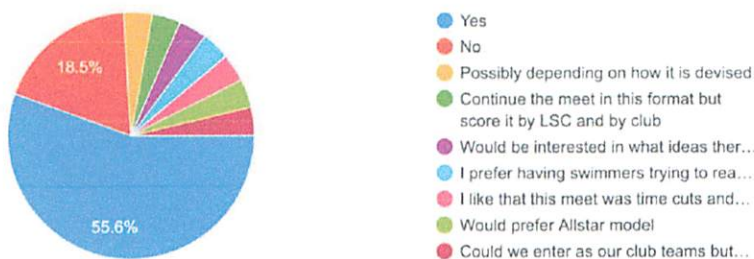
Would you be interested in going back to a LSC representation model (All Stars)?

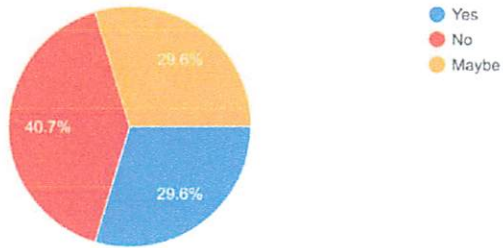

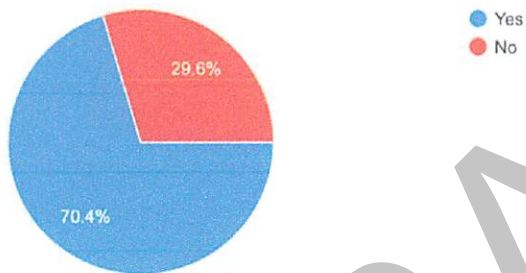
Do you think we would have the same number of swimmers if we reverted back to an LSC vs LSC model?

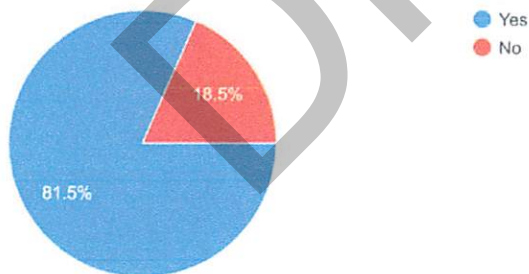
Would you encourage or discourage your swimmers to attend if it was an LSC model?
